Subject: Relaxation/Rescheduling of Power Regulatory Measures on Industries.

Due to improvement in Power supply Position and decrease in load on the system, following relaxations were given through various telephone messages as under:

- 1 Industrial consumers feeding from Cat-II feeders (except Induction and Rolling mill consumers) were allowed to observe weekly off day from 0800 hours to 2100 hours instead of 0800 hours to 0800 hours of next day w.e.f 7.11.09 to 14.11.09 and 30.11.09 to 14.12.09.
- 2 Arc/Induction furnace and Rolling mill consumers were allowed to use power from 2100 hours to 0600 hours during weekly off days. Thus these consumers were to observe weekly off day from 0600 hours to 2100 hours instead of 2100 hour to 2100 hours w.e.f 7.11.09 to 14.11.09 and 30.11.09 to 14.12.09. Days of weekly off day remained unchanged.
- 3 Weekly off day for consumers falling on Cat-II & III feeders including Arc/Induction and rolling mill consumers was relaxed from 15.11.09 to 29.11.09.

Subject: Relaxation/Rescheduling of Power Regulatory Measures on Industries.

Due to decrease in demand and as per availability of power following relaxation/rescheduling in power regulatory measures was intimated through telephone messages as under:

1. 1st and 2nd Weekly off day falling on 11.09.09 for Industrial consumers feeding from Cat-II & III feeders including Arc Induction and rolling mills was relaxed up to start of peak load restriction of 12.09.09.
2. All LS industry consumers feeding from Cat-II, III and IV feeders were allowed to use
 - (i) 100% Peak load exemption instead of 75% for 11.9.09, and w.e.f 8.10.09 to onwards till further orders.
 - (ii) 75% Peak Load Exemption instead of 50% 5/9/09 to 23.9.09 (excluding 11/9/09) w.e.f 4.10.09 to 7.10.09
 - (iii) 50% Peak Load Exemption instead of 75% w.e.f 24.9.09 to 3.10.09
3. Peak Load Restrictions on Cat-IV Continuous process consumers:-
 - (i) Were increased from 6 hours to 12 hours w.e.f 24.9.09 to 11.10.09.
 - (ii) Relaxed from 12 hours to 6 hours for 12.10.09.
 - (iii) Relaxed to normal 3 hours w.e.f 13.10.09 onwards.
4. Peak Load Hour restrictions which were imposed for 6 hours on Arc Induction and rolling mill consumers vide PR Circular 31/09 dt 5.9.09 were withdrawn and normal Peak load hours restrictions of 3 hours remained applicable w.e.f 12.10.09 to onwards.
5. 2 weekly off days were imposed instead of 39 hours on all industrial consumer feeding from Cat-II feeders (except Arc Induction and rolling mills) w.e.f. 24.9.09 to 7.10.09. Timings and day of weekly off days remained unchanged. For example consumers whose 1st weekly off day was falling on Wednesday were to observe weekly off day from 0800 hours of Wednesday to 0800 hours of Friday and so on.
6. Induction and rolling mill consumers were to observe 3 weekly off days instead of 2 weekly off days w.e.f. 24.9.09 to 7.10.09 Timings and day of weekly off days remained unchanged.
7. Arc Furnace consumers were to observe 3 weekly off day instead of 2 weekly off day w.e.f 24.9.09 to 5.10.09.
8. 2nd weekly off day of Cat-II consumer falling on 8.10.09, 9-10-09, 10-10-09 was relaxed.
9. All LS consumer feeding from Cat-II feeders (except Arc Induction & Rolling Mill consumers) were allowed to observe weekly off day for 37/37.5 hours instead of 2 days (48 hours) w.e.f. 11.10.09 onwards. Time of weekly off day was to start from the start of peak load hour restriction of 1st weekly off day up to 0800 hours of day next to 2nd weekly off day. Thus the consumer whose 1st weekly off day was on Saturday were to observe weekly off day from the start of peak load hours restrictions of Saturday up to 0800 hours of Monday and so on.

10. Induction furnace and rolling mill consumer were allowed to observe 2 weekly off days instead of 3 weekly off days from 8.10.09 to 13.10.09.
11. Two weekly off days were applicable on Arc furnace consumers from 6.10.09 to 13.10.09.
12. As per PR circular No. 33/2009 dated 13.10.09 Power Regulatory Measures were brought to Normal level w.e.f. 14.10.09 to onwards as under:
 - (i) One Weekly off day on Cat-II (except Arc Induction and rolling mills) consumers.
 - (ii) One Weekly off day on Arc/Induction and Rolling Mill consumers.
 - (iii) Only 3 hours Peak Load Restrictions on all Categories of consumers made applicable w.e.f 13.10.09.
13. Weekly off day for all industrial consumers feeding from Cat-II & III feeders including Arc Induction and rolling mill consumers falling on 18.10.09 was relaxed.

Subject: Relaxation in Power regulatory measures.

Due to decrease in demand of power, it is decided to bring the Power Regulatory Measures on industry to normal level. Accordingly, Normal one day weekly off day and 3 hours Peak load restriction will be applicable on industries as under:

1. All industrial consumers being fed from Category-II feeders (except Arc/Induction Furnace and Rolling Mills) will observe one weekly off day instead of 37/37.5 hours being presently observed. Day of weekly off day will remain unchanged as already intimated. These consumers will observe weekly off day from 0800 hours of weekly off day up to 0800 hours of the next day. For example, consumers whose weekly off day is falling on 14.10.09 (Wednesday), will observe weekly off day from 0800 hours of 14.10.09 (Wednesday) up to 0800 hours of 15.10.09 (Thursday) and so on.
2. Arc/Induction furnace & rolling mills consumers will also observe one day weekly off day instead of 2 days as being presently observed. Timing and day of weekly off days will remain unchanged. For Example, consumers whose weekly off day is falling on 14.10.09 (Wednesday), will observe weekly off day from end of peak load hours of 13.10.09 (Tuesday) up to end of peak load hours of 14.10.09 (Wednesday).
3. All LS consumers including consumers being fed from category-IV feeders will observe Peak load restrictions for 3 hours w.e.f. 13.10.09.

Subject: Relaxation in Power Regulatory Measures on Industries.

Due to Improvement in power position, following relaxation in Power Regulatory Measures was given through Telephone Messages in the month of September up to 4.9.09 as under:

1. 2nd and 3rd Weekly off days of all Industrial consumers being fed from Category-II feeders (except Induction Furnace and Rolling Mills) falling on 01.09.2009 were relaxed from 0800 hrs to 1830 hrs of 01.09.09. Also 3rd Weekly off day of these consumers falling on 02.09.2009 was relaxed up to 1830 hrs of 2.09.09. 1st, 2nd and 3rd Weekly off day of these consumers falling on 03.09.09 was also relaxed up to 18.30 hours of 3.9.09.
2. 2nd Weekly off day for Induction furnace & rolling mills falling on 01.09.09 was relaxed up to start of Peak Load Restrictions of 01.09.2009. Induction furnace and Rolling Mills consumers feeding from Cat-II & III feeders were allowed to use power from 04.30 hrs to 1730 hrs instead of 0530 hours to 1730 hrs. w.e.f. 4/9/09 to till further orders.
3. 4th Weekly off day falling on 01.09.09 for Arc Furnace consumers was relaxed up to start of Peak Load Restriction of 1.9.09.
4. All LS consumers feeding from category-IV feeders were allowed to use 75% Peak Load Exemption instead of 50% from 2300 hours of 2.9.09 to the end of extended peak load hours restrictions of 2.9.09 only.

5. All restrictions imposed on all type of industries (including all weekly off day s restrictions and extended Peak Load Restrictions) were relaxed from 1600 hrs of 03.09.09 to 0800 hrs of 04.09.09. Also 100% Peak Load Exemption was allowed during this time to all LS consumers. However, usual Peak load restrictions of 3 hrs remained applicable.
6. All Weekly Off Days on arc furnaces consumers falling on 4/09/09 were relaxed up to start of PLR dated 4/09/09. 2nd Weekly Off Day of induction & rolling mills consumers falling on 4/09/09 was relaxed up to 17:30 hrs dated 4/09/09. 3rd Weekly Off Day of Industrial Consumers being fed from Cat-II feeders falling on 4/09/09 was also relaxed.
7. I) Induction furnaces & rolling mill consumers who were using power up to 17:30 hrs. of 4/9/09, were allowed to use power up to start of peak load hours of 4/9/09.
 II) Induction furnaces & rolling mill consumers Whose Weekly off day was not on 5/9/09, were allowed to use power from end of peak load restrictions of 4/09/09 up to 17:30 hrs of 5/9/09.
 III) 2nd weekly-off day of Induction furnaces & rolling mill consumers falling on 5/9/09 was relaxed from end of peak load restrictions of 4/9/09 up to 17:30 hrs of 5/9/09.
 IV) 4th weekly off day of Arc furnace consumers falling on 5/9/09 was relaxed.
 V) 100% peak load exemption was allowed to all industry consumers (feeding from Cat-II, III & IV feeders) instead of 50 % for 4/9/09 only. However, extended PLR of 12 hours remained applicable on continuous process Cat-IV consumers.

Subject: Relaxation in Power Regulatory Measures on Industries.

In continuation to previous PR circular issued by this office resting with PR –Circular -30/2009 dated 2.09.09 ,it has been decided to reschedule power regulatory measures on industries with immediate effect ,till further orders ,as under :

- 1) All industrial consumers feeding from category-II feeders (except induction furnace and rolling mill consumers) will observe weekly off day for 39 hours instead of 3 weekly off days being observed presently. Time of weekly off days will start from 08:00 hrs of weekly off day and end at 23:00 hrs of next day. 3 hrs Peak Load Restriction on LS consumers as being imposed will remain applicable on these consumers
- 2) All Arc/induction furnace and Rolling mill consumer (feeding from category-II and III feeders) will observe two weekly off days. However, LS consumers will observe extended peak load restrictions for 6 hours instead of present 3 hours. Time of weekly off days will start from the end of peak load restrictions of previous day and end at the end of peak load restrictions of next day. For example if weekly off day of a consumer falls on Sunday ,it will start from the end of peak load restrictions of Saturday and end after the end of peak load restrictions of Monday .Further peak load restrictions for consumers under Central zone will be from 19:00 to 01:00 hrs of next day and for consumers under zones other than central zone will be from 18:30 hrs to 00:30 hrs of next day for the month of September and so on
- 3) All continuous process Category IV LS consumers will observe peak load restrictions for 6 hours instead of 12 hours being observed presently.
- 4) All LS consumers feeding from cat-II,III and IV feeders are allowed to use 75 % Peak Load Exemption allowed instead of 50 % being used presently.

These relaxations come in force with immediate effect till further orders. Days of weekly off days will remain the same as already intimated.

Other terms & conditions including penalty for violation for the above instructions issued by this office vide previous Circulars will remain unchanged. It is requested that all the concerned consumers be informed accordingly.

Subject: Power Regulatory Measures on Industries.

Due to shortage of power following Power Regulatory Measures were taken through telephone message in the Month of August as under:

- 1 Arc Furnace consumers were allowed to use power for 12 hours each day for 5 days week instead of 21 hours each day for 3 days in a week from 12.8.09 to 25.8.09. Timings for use of load were 0430 to 1630 hours from 12.8.09 to 13.08.09 and 0530 to 1730 from 14.8.09 to 25.8.09. Two days Weekly off days were applicable on Arc Furnace consumers during this period. These consumers whose 1st and 2nd weekly off was not falling on 12.8.09 were to use power for 12 hours wef 12.8.09. After 25.8.09 ie w.e.f. 26.8.09 these consumers were to use power for 21 hours a day for 3 days with four weekly off days as PR circular No 27/2009 dt 17.8.09.

- 2 All LS consumers feeding from Category II, III, and IV be allowed to use Peak Load Exemption allowed upto 75% instead of 50% on 18.8.09, 19.8.09, 20.8.09, 22.8.09 to 24.8.09 & 30.8.09.

Subject: Rescheduling Power Regulatory Measures on industrial consumers fed from Category-II, III and Category-IV feeders.

To meet the gap between demand and power supply due to paddy load and delayed Monsoon, it has been decided to reschedule Power Regulatory measures on industrial consumers, as under:-

1. Third Weekly Off day is imposed on all industrial consumers being fed through category-II Feeders w.e.f. 29.06.09. Thus these industrial consumers whose second Weekly Off day falls on 28.06.09 (Sunday) will now observe third Weekly Off day on 29.06.09 (Monday) and so on.
2. Peak Load Exemption allowed to Category-IV Continuous Process L.S. consumers and L.S. consumers feeding from Category-II and III feeders are hereby reduced to the extent of 50 % allowed to them by this office or by SE/DS concerned w.e.f. 28.06.09.
3. Arc, Induction Furnaces and Rolling Mill Consumers are allowed to use Power from 06:00 Hrs to 16:00 Hrs daily w.e.f. 29.06.09 (Monday) and instructions to complete shutdown of these industries upto 12:00 Hrs of 02.07.09 are hereby withdrawn w.e.f. 06:00 Hrs of 29.06.09. However the consumers will remain under shutdown during the period from 16:00 Hrs to 06:00 Hrs of next day daily.

These instructions will remain in force till further instructions. The other terms & conditions including penalty for violation for the above instructions issued by this office vide previous Circulars will remain unchanged. It is requested that all the concerned consumers be informed accordingly.
