However, though unions/associations may be working /operating under the platform which is not still got registered from the office of Registrar trade unions ,their members shall fill the code of their respective independent union/association in the requisite Survey Performa to be filled in by each employee which is enclosed herewith. Each office under your control is desired to get it completed and signed employees-wise for record in his office. On the basis of this collected data recorded from each individual employee, the information may please be furnished in **annexure B**. The fresh union code list is mentioned in **annexure A**.
